There are still several fields in which you will have to provide information. Any that have a red * are required fields.

- County that the address where you are digging is located.
- Place/City that the digsite address is in or near.
- Type of Place the digsite is in. City=Inside City Limits County=Outside the City Limits CDP=Census Designated Place
- The nearest intersection/cross street is not mandatory, but it is helpful in making sure your address is found at the correct location. In the example below Scott Bolin Rd runs North and South, and intersects KY RT 927, which runs East and West.
- Indicate what part of the property you want located. At least one choice must be made, and multiple choices are allowed too (e.g. Front of Lot and Rear of Lot, etc.)
- After you have filled in all of the fields, click on “Next” to continue.

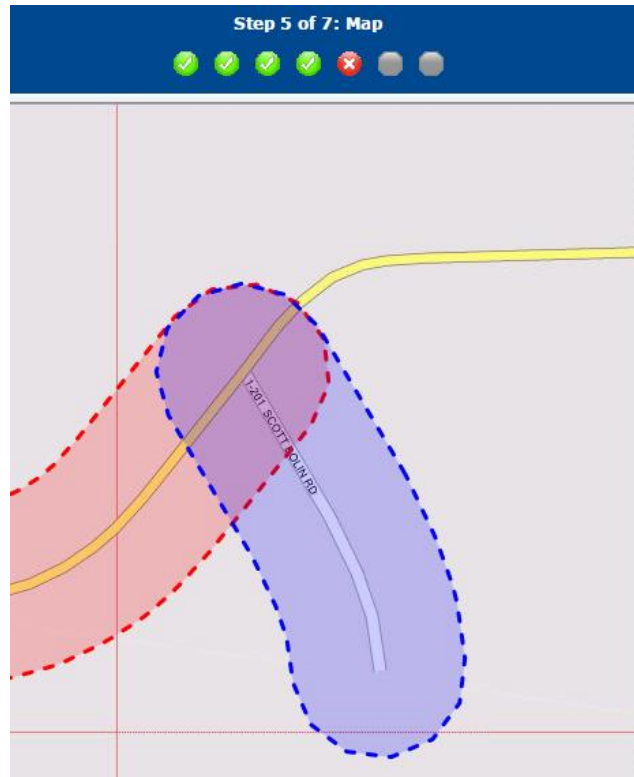
